

#### Amendment of Directive 2010/63/EU on the protection of animals



In March 2024, the European Commission amended the annexes to Directive 2010/63/EU on the protection of animals used for scientific purposes. These new requirements, which will be effective from December 2026, cover the care, housing and killing methods of cephalopods, zebrafish, passerines and rodents. <u>Find out</u> more
